PROJECT DESCRIPTION: During this course you will be required to select a training topic required by OSHA safety standards. Then you will analyze training needs; develop a training program; choose proper training methods and materials; and present a portion of that program to a trainee audience.

FIRST MILESTONE: You will turn in a paper with the following information:

# Part 1:

Audience (Trainee) Analysis

You have been given a document describing your training audience. From what you are able to learn from the document, and from assumptions of your own, provide an analysis of that audience relative to the topic you have chosen. In other words, what do you expect they will already know (knowledge, skills, etc.), and what do they need to know to do the job you have chosen successfully and safety, and what will you need to teach them (the training discrepancy).

#### Part 2:

**Training Analysis**

  - 3. Break that job down into tasks. List them.
  - 4. Select at least one of the tasks on which you will develop a training course. Do a Job Task Analysis (JTA) on that task(s)
    - Select one task.
    - Break that task down into steps.
    - Define the skills associated with each step.
  - 5. Create a skills hierarchy, showing which skills must be learned before others can be taught.
    - Write a proper Terminal Objective; i.e., what will a trainee be able to do when he/she has completed your training.
    - Write a proper objective for each skill you have identified as needing to be taught.
